So are you still on the fence about putting your koi or goldfish in the Show? Let us put your mind at ease. It is very easy to enter. First, just contact Charles or Carolyn Phelps to reserve a show tank. You will find in this month's newsletter, the instructions and entry forms for koi and goldfish. We will help you fill out the forms if you don't know the size or variety to mark on the forms. Each show has a novice class for first time showers. If you have not entered a fish show before, you are eligible for this award.

Remember, the 12" koi do not compete against the 28" koi. So, it is not necessary to have large fish to win an award. The Baby Grand Champion is chosen from 12" or less and Junior Grand Champion is 20" or less. Also, there are awards given for each variety. The same goes for the goldfish. There are awards for the smaller fish and larger fish and of each variety.

KOI 101 - April Lesson

During this time, please observe your koi and goldfish closely for sores and ulcers. Along with starting our filtering systems, beginning to feed our fish, and the decaying matter that has accumulated over the winter (which we need to remove) are all a sources that can cause fish issues. One way to check our fish is to hand feed or get as close to the fish when we feed them. The two areas that seem to be prone to sores and ulcers are "Where the food goes in and where the food goes out". Plus, under the pectoral fins and belly region of the fish.
